All work performed within the Airport boundaries is subject to inspection by Building Inspection and Code Enforcement for compliance with the Airport Commission Tenant Improvement Guide which serves as the construction standards. The approved drawings and specifications, along with the Building Permit, shall remain on the job site during the course of the project. The Building Permit must be completed by the inspectors. After the final inspection, a certificate of final completion will be issued by Building Inspection and Code Enforcement. A separate permit is required from the Airport Fire Marshal for welding, burning or other open flame. Personnel ID badges and vehicle passes are required for work within the secured areas of the Airport. The contractor's activities shall not unduly interfere with the normal operation, safety or security of the Airport.

NOTICE TO APPLICANT
